COFFEE COUNTY HEALTH DEPARTMENT

Coffee County Health Department offers clinical services to the public, including family planning, women's healthcare, vaccinations, and clinical laboratory testing. The facility can assist with ALL Kids, WIC, and Medicaid enrollment, as well as provide referrals for home care services and remote patient monitoring services. This location can also schedule environmental services and provide certified copies of birth, death, marriage, and divorce records.

Interpretive services are available.

Appointments must be made via phone.

This clinic accepts Medicare, Medicaid, VA and Tricare, Blue Cross Blue Shield, and other private insurance. This is a healthcare center funded by the federal government. This means even if you have no insurance, you can be covered.

The Coffee County Health Department Home Care Program uses a holistic approach to provide home health care services prescribed by a physician to residents of Coffee County. Services are delivered to qualified homebound Medicare, Medicaid, or commercial insurance recipients.

A home health team of highly trained professional staff provide care on an intermittent part-time basis in the privacy of the home to acutely and/or chronically ill individuals. Services provided may include: Skilled Nursing, Physical Therapy, Medical Social Services, and Home Health Aide.

Home Care Program staff can provide disease management of many conditions and symptoms that were previously limited to the hospital setting, including: Post-surgery Care, Heart Failure, COPD, Diabetes Mellitus, Hypertension, Stroke, Wound Care, Pediatric Care, Arthritis, Alzheimers, Muscle Skeletal Conditions, Medication Teaching/Management

Office hours for the Home Care Program are 8:00 a.m. to 5:00 p.m. Monday through Friday, excluding holidays. Skilled Nursing Services are available 24 hours a day, seven days a week, including holidays. Eligibility varies by the insurance and reimbursement requirements, and by each individual's specific medical needs. A physician order is required for all services.
