Lee County Health Department offers clinical services to the public, including family planning, women's healthcare, vaccinations, and clinical laboratory testing (including STD and TB testing). The facility can assist with ALL Kids, WIC, MAPS and Medicaid enrollment, as well as provide referrals for home care services and remote patient monitoring services. This location can also schedule environmental services and provide certified copies of birth, death, marriage, and divorce records as well as VITAL records.

Appointments with a nurse practitioner are available Monday, Wednesday, and every other Friday. Telehealth appointments are available for select patients.

Translation/interpretive services are available.

This clinic accepts Medicare, Medicaid, and most private insurance. This is a healthcare center funded by the federal government and offers a sliding-scale payment model. This means that if you are uninsured, the cost of your medical service is based on your income and ability to pay.
