BULLOCK COUNTY HEALTH DEPARTMENT

The Bullock County Health Department offers women's healthcare, family planning, vaccination, and lab testing (including STD, COVID-19, and Tuberculosis testing) in their clinic. The Health Department can coordinate home health services to qualified patients and assist with enrollment in Medicaid, WIC, and ALL Kids. The clinic also assists with environmental services. Vital records including birth, death, marriage, and divorce certificates can be obtained onsite.

Interpretive services are available.

Nurse practitioner appointments are available on Wednesdays.

Walk-ins & appointments are available; however, appointments must be scheduled by phone.

This clinic uses a sliding-scale payment model, which means that for those without insurance the price of services is based on your income.

The Bullock County Department of Human Resources programs include Temporary Assistance for Needy Families (cash assistance, employment, and training service). They also provide Supplemental Nutrition Assistance Program (food stamps, employment, and training services); Food and Nutrition Programs (emergency food assistance, programs for seniors, healthy eating activities); and Child Care Assistance. The Bullock County DHR hours of operation are Monday-Friday from 8:00AM-4:30PM.

Gateway at Bullock County Hospital offers inpatient psychiatric care for adults ages 19-54 whose acute symptoms require a safe and structured therapeutic environment.

Golden Years:

The team of clinical specialists at Bullock County Hospital offer acute psychiatric stabilization for older adults with dementia, depression, anxiety, late life mood disorders, and other symptoms of psychosis.

Inpatient Medical Unit:

The Inpatient Medical unit at Bullock County Hospital treats patients that require either chronic or acute level care.
